QUALITY FOCUS ESSAY (QFE)

The QFE is a new component to the Self-Evaluation Report. As described in ACCJC's *Manual for Institutional Self-Evaluation*, "Within the accreditation focus on continuous quality improvement, the institution will identify two or three areas coming out of the institutional self-evaluation on which the institution has decided to act (action projects), and which will have significance in improving student learning and student achievement over a multi-year period" (page 21). Solano Community College, after collegial collaboration over several months, decided to focus on:

IMPROVING INTEGRATED PLANNING

Despite positive efforts, there is still work to be done in defining the ongoing cycle of evaluation, planning, resource allocation, and implementation. The following efforts are directed toward continuous improvement:

- **Planning Database Management:** A new Office of Research database will help the College track and report on the progress of goals and outcomes
- **Academic Program Review:** The template has been revised to align more closely with accreditation standards and to support the linking of institutional planning to resource allocation
- Non-Academic Program Review: The College has taken steps to re-start this process
- **Linking Planning to Resource Allocation:** Institutional planning is re-focused on providing resources to support collaborative efforts to achieve the College mission

IMPROVING STUDENT LEARNING OUTCOMES ASSESSMENT

SCC has made significant strides around outcomes and assessment. Additional efforts include:

- SLO Quality Rubric and Assessment Form: Both were revised by the Assessment Committee
- Faculty-Created Common Assessment Rubrics: Helpful for classes with multiple sections
- **Discover Best Practices in Disaggregation of SLO Data:** We need to find ways to look closely at student data in meaningful ways
- Effective Assessment Management Database: The upgrade to CurricUNET META will facilitate this

The College is clear in its *Self-Evaluation Report* about areas of needed improvement: if you are asked about this by members of the visiting team, don't be afraid to say, "Yes, we have struggled with some things, but we are working on getting better!"
