Dr. Rischa Slade:

Hurricane Harvey: Superintendent President Esposito-Noy sent out an email on the ASSC's Club Promo's Hurricane Harvey trifold and it was well-received.

DACA: The California COmmunity Colleges Chancellor Eloy Ortiz Oakley issued a statement on the Trump administration's action to end DACA: "... We will do all within our power to assist students affected by this decision, and we will advocate tirelessly in Congress for a permanent resolution to this issue".

Guest Speaker - Lt. Travis:

Commanding officer for all law enforcement on Solano College. He wants to talk about DACA. The officers on campus will not be doing anything differently, asks for ID, driver's registration, and proof of insurance. Just here to protect the students, not question your status. The Safety Committee & VP Brown - will be getting speed bumps in the back of the campus on the stretch of road that drivers like to speed. For safety for both students and people on campus, and the cats on campus.

Don't forget to lock up your belongings and carry your things with you. It's an open campus.

Coin program -- doing good things, acts of kindness. If the officers see you doing it, you could get a coin.

Guest Speaker - Kevin Richmond, Treasurer for the Drama Club:

This summer, Drama Club went to the Ashland, Oregon Festival. They saw four shows, both in a Thomas Theatre and an Elizabethan Theatre, with an equity after, and a backstage tour. They got information on transferring, learned a lot in general, and are hoping to bring that information and inspiration to the on-campus Theatre with four or five shows this year. They also hope to use Studio G which is a dynamic and versatile space. It was a five-hour drive. They wanted to thank the ASSC for the grants and support because, without the funding, they wouldn't have been able to stay overnight, and driving back up put their student drivers at risk because of the long drive and lack of sleep.
