VI. ADVISOR'S REPORT/ GUEST SPEAKER(S) (10:00 Minutes)

- A. Alexandria Castaneda
 - 1. ASSC members must check the ASSC bylaws and know their respective duties.
 - 2. CC Advisor Castenda when emailing the deans, presidents, and vice presidents.
 - 3. Members must give Advisor Castaneda a 48 hours notice before a meeting.
 - 4. The Student Concerns Committee already submitted their Spring Schedule to Advisor Castaneda.
 - 5. The Foodbank will be at Solano Community College's main campus from 2PM to 3PM and at the Vallejo and Vacaville Center from 3:30 PM to 4:30 PM on December 9th, 2020.
 - COVID-19 FALL 2020 Withdrawal Agreement is due December 11th, 2020 at 5PM.

- B. RAD Region II Anjali Patel
 - 1. Discussed the SSCCC Diversity, Equity, and Inclusion (DEI) Resolution.
 - 2. The resolution highlights why DEI is important. This resolution is an answer to Trump's statement of cutting funds for any organizations that tackle DEI.
- C. LAD Region II Jasmine Praasad
 - 1. Discussed the COVID-19 Block Grant Advocacy.
 - 2. Discussed the Advocacy Toolkits.
 - 3. Solano Community College is entitled to approximately \$670,000 that can be used to support students that are highly impacted by the COVID-19.
 - 4. Legislative visits provide lobbying training for the SBA officers.

VII. ACTION ITEMS (5:00 Minutes per item)

- A. Approval of "Old Business" as another section in the agenda and minutes.
 - 1. "Old Business" will become the first sub-section under Section VII: Action Items and Section VIII: Information Items.
 - 2. Senator Westbrook moved to approve "Old Business" as the first sub-section under Section VII: Action Items and Section VIII: Information Items. The motion was seconded by Senator Simonova. There was no discussion. The motion was passed by consensus.
- B. ASSC Senate Bill #19-5 is for the purchase of a banner and one table runner. The Senate Bill #19-5 must not exceed \$400.00.
 - 1. Members reviewed the banner and the table runner options and their prices. Option A, which is 34"x81" double sided retractable banner and 36" one table runners all-over print for \$343.73, is chosen. Standard shipping for the items, which costs \$11.99, is chosen. The overall total is \$355.73.

- 2. Discussed the logo and design for the table runner.
- 3. Senator Sharififard moved to approve the Student Senate Bill #19-5, which is for the purchase of a banner and one table runner. The motion was seconded by Senator Westbrook. Legislative Advocate Chan, Senator Bermudez, Senator Allen, Senator Simonova, Senator Sharififard, Senator Westbrook, and Senator Maciel all voted in favor of the Senate Bill #19-5. No nays or abstains. Seven out of seven voted in favor of the Student Senate Bill #19-5 for the purchase of a banner and one table runner. There was no further discussion. The motion was passed.
- C. ASSC Senate Bill #2020-10 is the Winter Wish Program Donation to ELC. The Senate Bill #2020-10 for the ELC Winter Wish Giving Program must not to exceed \$300.00.
 - Senator Sharififard moved to approve the Student Senate Bill #2020-10, which is for the ELC Winter Wish Giving Program. The motion was seconded by Senator Westbrook. Legislative Advocate Chan, Senator Bermudez, Senator Allen, Senator Simonova, Senator Sharififard, Senator Gard, Senator Westbrook, and Senator Maciel all voted in favor of the Senate Bill #2020-10. No nays or abstains. Eight out of eight voted in favor of the Student Senate Bill #2020-10 for the ELC Winter Wish Giving Program. There was no further discussion. The motion was passed.
 - 2. Senator Westbrook moved to extend the time to discuss item VIIC for three more minutes. The motion was seconded by Senator Maciel. There was no further discussion. The motion was passed.
 - 3. Discussed the past donations of ASSC to the ELC and the Direct-Pay Form.

- A. Discussion of the App Builder U
 - 1. For the App Builder U, the one time development cost is \$5000 and \$500 for a monthly hosting and app update.
 - 2. Senator Bermudez disagrees about purchasing the App Builder U because of its limited features and discussed improving the SCC app instead.
 - 3. Senator Sharififard moved to extend the time to discuss item VIIIA for five more minutes. The motion was seconded by Senator Maciel. There was no further discussion. The motion was passed.
 - 4. Senators agreed to advertise and improve the SCC app rather than purchasing the App Builder U. Members must download the SCC app to explore it and to prepare for it's discussion in the next meeting.
