A. Ballot Count

<u>Ballot count procedure:</u> The ballot box was unlocked by Advisor Ghous and opened by Chair Baig. Ballots were separated by day as indicated by color: Monday's ballots were

blue, Tuesday's ballots were salmon, Wednesday's ballots were gold, and Thursday's ballots were purple. The ballots were read out loud by Chair Baig, verified by Members Friere and Bram, and then recorded. Any ballots that seemed unclear or invalid were put aside and reexamined after each day's tally.

**Monday**: 37 total ballots were cast. 1 was declared entirely void.

Presidential/ Vice Presidential ticket: 32 ayes, 2 nays, and 1 void for Ferrel/ Brown. 1 write-in for "Brooke Hudson/ Nicole Carter."

Student Trustee ticket: 30 ayes, 4 nays, and 2 voids for Salazar. No write-ins. Legislative Advocate ticket: 29 ayes, 2 nays, 5 voids for Buford. No write-ins.

Motion to approve the ballot count for Monday, September 24, 2012 by Chair Baig, second by Member Bram. **Motion unanimously carries (5,0,0).** Member Pua left the meeting at 12:57 pm.

**Tuesday**: 32 total ballots were cast. 1 was declared entirely void.

Presidential/ Vice Presidential ticket: 27 ayes, and 1 void for Ferrel/ Brown. 1 write-in for "Charles Anderson/ Cassie Ordonio." 2 additional ballots were deemed clear enough to accept; 2 additional ayes for Ferrel/ Brown.

Student Trustee ticket: 27 ayes, and 1 void for Salazar. No write-ins. 3 additional ballots were deemed clear enough to accept; 3 additional ayes for Salazar.

Legislative Advocate ticket: 25 ayes, 1 nay, 2 voids for Buford. No write-ins. 3 additional ballots were deemed clear enough to accept; 3 additional ayes for Buford.

Motion to approve the ballot count for Tuesday, September 25, 2012 by Chair Baig, second by Member Freire. **Motion unanimously carries (4,0,0).** 

**Wednesday**: 34 total ballots were cast. 1 was declared entirely void.

Presidential/Vice Presidential ticket: 29 ayes, 3 nays, and 1 void for Ferrel/Brown. No write-ins.

Student Trustee ticket: 29 ayes, 3 nays, and 1 void for Salazar. No write-ins.

Legislative Advocate ticket: 29 ayes, 2 nays, 2 voids for Buford. No write-ins.

Motion to approve the ballot count for Wednesday, September 26, 2012 by Chair Baig, second by Member Bram. **Motion unanimously carries (4,0,0)**.

Thursday: 14 total ballots were cast.

Presidential/Vice Presidential ticket: 13 ayes, and 1 nay for Ferrel/Brown. No write-ins.

Student Trustee ticket: 13 ayes, and 1 void for Salazar. No write-ins.

Legislative Advocate ticket: 13 ayes, and 1 void for Buford. No write-ins.

Motion to approve the ballot count for Thursday, September 27, 2012 by Chair Baig, second by Member Freire. **Motion unanimously carries (4,0,0).** 

**Final Tally:** 117 total ballots were cast. 3 were declared entirely void. There were 114 accepted ballots.

Presidential/ Vice Presidential ticket: 103 ayes, 6 nays, and 3 voids for Ferrel/ Brown. 1 write-in for "Brooke Hudson/ Nicole Carter." 1 write-in for "Charles Anderson/ Cassie Ordonio."

Student Trustee ticket: 102 ayes, 7 nays, and 5 voids for Salazar. No write-ins.

Legislative Advocate ticket: 98 ayes, 5 nays, and 11 voids for Buford. No write-ins.

Motion to approve the final tally count of ballot by Chair Baig, second by Member Bram.

Motion unanimously carries (4,0,0).
