Discussion: For clarity Joe asked for a summary of reasons for adding a unit to English 001.

Michael Wyly read the English Department letter that was emailed on April 30. Points included:

1. To conform to the C-ID description and UC articulation agreements; course descriptions have increased in content commensurate with a one unit increase.
2. While the C-ID descriptor doesn't require four units, the requirement of 6,000 formal words for each course will require four units of lecture; the same requirements exist for English 002, already a four unit course at Solano College; a new baseline is established and needs to be consistent across the discipline for pedagogical and ethical reasons; the actual work-load of students is much greater; students in transfer-level courses in English composition confirm an increase in work-load in excess of other three-unit courses and a need for the appropriate-levels of instruction and support.
3. A look at other community colleges with strong, successful programs in English supports this change for student retention and success in English, and to put SCC courses in-step with state-wide trends.
4. A desire to increase student success rates in transfer/degree -oriented courses in English composition.
5. All full-time faculty in English support these curricular changes and the new unit value required.

Joe reported that he was given a statement signed by 15 members of the English department in support of the one unit increase. Jeff opined the pedagogical arguments are compelling regarding student work and expectations but, from the department administrative perspective, staffing, scheduling and cost implications put this increase request in a much different light. Due to district fiscal responsibilities, he would vote no. Maire shared multiple concerns including: every student on campus has to take English 1, and due to the LR10 co-requisite, the increase would effectively make it a five-unit class; student success has still hovered around 65-68%, so adding LR10 wasn't effective; if there is data to show students will be more successful every instructor would increase their course units to guarantee success; the C-ID descriptor recommends, but does not require, between three and four units. English faculty argued that it shouldn't be kept at the minimum if work expectations equal four units; the increase will give them extra instructor time for support; with so much effort put into this issue, information from other community colleges, student surveys, and the rationale, it should not be an arbitrary decision; Toni asked why it is being debated when students have this workload and want teachers to give them the support needed without being overworked.

Joe read the PCAH criteria to use for curricular decisions: appropriateness to mission; need; curriculum standards; adequate resources; compliance. He also noted that the Committee can and should be taking into account if the district has adequate financial resources. There were no compliance issues; the appropriateness to mission didn't seem to apply; issues with curriculum standards were in question.

Debra stated that CTE has concern that, due to English 1 affecting every program and graduation requirements: this decision shouldn't be made without getting input from everyone on campus; there are already programs mandated by state and federal guidelines with well over 60 units; teachers would have to redesign some of their courses as they can't just be cut; CTE is voting no due to damage to curriculum and many changes that would have to be made. Toni asked if there were areas, other than CTE, that could negatively affect students if the increase were made. Maire noted that nursing has transfer model curriculum held to 36 nursing units, the other 34 general education units would come from campus-wide courses; students have financial aid issues due to the extra units, or students won't get their degree, or fire, for example, has to cut something from core curriculum, but they also have advisory or mandatory courses; any change to graduation requirements affects other departments and courses. Josh argued that is a separate concern; the department has proved a unit increase will be beneficial to student progress etc.; a separate solution would be needed for CTE or other programs. Debra responded that Solano College has a higher number of CTE programs than most schools in the state and would have more negative impact.

11. REPORT FROM THE CHAIR

At a conference Joe attended last weekend, he learned there are over 100 community colleges submitting math proposals, but only two CSU reviewers, so the whole system is at a standstill for math. Robin noted it is the same for other courses.
