(a) <u>Academic Senate</u>

Prof. Michael Wyly, chair of the Academic Senate, provided the following report:

President Young, Vice-President Martin, Trustees of the Board, Superintendent-President Arterberry, Colleagues, Members of the Public:

As our last meeting of the Senate was interrupted by the campus closure, I have only two items to report this evening:

Since my last report, I had the opportunity to meet with Vice-President Brown to discuss in detail how the Senate can best serve the needs of the College in regards to the successful submission of SSSP and Student Equity Plans. We developed a sound plan and calendar to allow for clear vetting as well as the necessary approval process. I want to convey my current optimism for a transparent and efficient process, and I look forward to reporting on its progression in the Senate in the coming months.

On Friday, November 13th, 2015, Solano College will host the 2015 Northern California Curriculum Institute in cooperation with the Academic Senate for California Community Colleges [ASCCC]. (As the Board may recall, Solano hosted the ASCCC CTE Listening Event in Spring 2015.) The Senate looks forward to playing host to representatives from across the state as well as representatives of the ASCCC Executive Board. As details emerge, the Senate will be sure to keep the campus community apprised.

Unless there are any questions, this concludes my Senate report.

(b) <u>Shared Governance Council</u>

Vice President Greg Brown provided the Shared Governance Council report. He reported that there was a discussion on campus safety in light of the recent events that have happened on college campuses.

(c) <u>Superintendent-President</u>

Superintendent/President Stan Arterberry reported that he attended the Vallejo Business Education Alliance (VEBA) Luncheon, and acknowledged two current SCC students, Dycmond Mitchell and Arieal Johnston, who received scholarships. He also reported that he attended the Cal Maritime 20th Anniversary celebration of being a member of the CSU System. He acknowledged the SCC Facilities Department for their handling of this week's water main break, and wanted to ensure that we have the appropriate equipment on hand should this happen again. He also commented that he will be ensuring that the campus receives appropriate disaster preparedness training so that we are eligible to receive FEMA funds.

He introduced Curt Johnston, Executive Director of the Solano Community College Education Foundation, who provided an annual report. Some of the highlights from the presentation included the following:

- The Alumni Campaign has a \$30,000 investment and the Foundation has introduced a Distinguished Alumni Program.
- In terms of business outreach, the Foundation has participated in 145 events.
- In terms of public outreach, SCC hosted the Hands-On Construction Career Fair, which included 700 high school and SCC students, and 15 trade union apprenticeship programs.
- The 70th Anniversary Gala included key note speakers Scott Zimmerman (Genentech) and Jim DeKloe (SCC Faculty) and the awarding of Distinguished Alumni and Alumni of the Year Awards.
- The Tee Off for Athletes Golf Invitational is nearly sold-out, and funds will benefit SCC athletic teams
- The Foundation has awarded \$37,500 in 63 need-based scholarships. The Solano Promise supports bridge programs of SCC.

Trustee Martin thanked Mr. Johnston and the Foundation for the outreach to the community. Trustee Brown asked how students apply for scholarships, and Mr. Johnston stated that through the support of Robin Darcangelo and the Financial Aid Office, the information is available on the SCC website. Trustee Chapman asked about the restricted funds for the tennis program, and Mr. Johnson confirmed that these were donated funds and specific for the tennis program use.

Trustee Brown asked for clarity of who takes accountability for projects that are in need of repair once they are signed-off. He believes that the attorneys were too aggressive in their interpretation of the bylaws and this may have the consequence of the bonds not being able to be passed.
