In 2015, we were asked to prepare a list of aspirational goals based on one-year goal and six-year goals in each of the following areas: Student performance and outcomes; accreditation status; fiscal viability; and compliance with state/federal guidelines.

Dean Peter Cammish was in attendance to answer any questions the Trustees may have. President Martin asked Dean Cammish to walk the Board through a couple of the indicators. Dean Cammish explained that these indicators are asked by the Chancellors office, some mandatory, some optional and we've tried to complete as many as possible. There are a set of indicators that are fiscal and a set of indicators that are related to student performance. The goal is to try and set long and short term goals related to fiscal health and student performance.
