GO-Biz, through the CyberCalifornia initiative, will coordinate a variety of cybersecurity resilience activities for businesses, including cybersecurity supply chain mapping, cybersecurity provider surveys, cyber physical security workshops and assessments, innovation vouchers, and cybersecurity labor market analysis. CASCADE will also support more general business resilience activities, including commercialization, diversification, supply chain outreach, and entrepreneurial skills development.

The overall program is divided into four (4) phases and 15 total projects. The projects are contemplated to be completed by sub-recipients as detailed below.

Planning Phase

The primary goal of the planning phase is to develop the management processes that will govern CASCADE. In addition, this phase will also support the gathering of foundational data related to the cybersecurity resilience projects of Phases 1-3. These subsequent cybersecurity activities will demonstrate that enhanced cybersecurity resilience can support modernization and diversification assistance goals, as well as enhance the innovation capacity and long-term sustainability of advanced industry supply chains within the defense sector. The Planning Phase includes the following projects:

- 1. Strategic alignment with other OEA plans (facilitated by GO-Biz)
- 2. Cybersecurity labor market analysis and skills gap analysis (conducted by California Community Colleges, San Francisco Bay Center of Excellence for Labor Market Research)

Phase 1 – Identify and analyze defense supply chain

The purpose of Phase 1 is to develop more specific data on the defense supply chain in California. This data will help to identify the communities, businesses, and workers that will be eligible for the subsequent Phase 2 and Phase 3 diversification, adjustment, and modernization activities. Phase 1 includes the following projects:

- 3. Cyber provider survey (conducted by California Manufacturing Technology Consulting)
- 4. Supply chain mapping (conducted by California State University San Bernardino)
- 5. Cybersecurity industry convenings (conducted by San Jose State University)

Phase 2 – Build awareness of supply chain resilience resources

Phase 2 activities will raise awareness of available resilience resources and programs for communities, businesses, and workers at risk of being negatively affected by changes in spending. In addition, Phase 2 activities will help strategic partners identify the workers and businesses that will be eligible for the diversification and adjustment programs provided in Phase 3. While the strategic partners responsible for Projects 6-10 submitted individual proposals, these supply chain resilience efforts will be combined into multiple-partner resource fairs. Each resource fair will offer a robust set of resilience programs and educational opportunities for attendees. As one potential example, a resource fair may include a supply chain resilience seminar (Project 6), a business diversification workshop (Project 7), and a cyber physical security awareness workshop (Project 8). Phase 2 includes the following projects:

- 6. Supply chain resilience seminars (hosted by East San Diego County Economic Development Council)
- 7. Regional supply chain workshops (hosted by California Community Colleges Small Business Sector Navigator)
- 8. Cyber physical security workshops (hosted by California Manufacturing Technology Consulting)
- 9. Cyber physical security assessments (conducted by California Manufacturing Technology Consulting)
- 10. Supply chain outreach (hosted by the Nehemiah Emerging Leaders Program)

Phase 3 – Develop business and worker resilience programs to bolster supply chain

During Phase 3, strategic partners will deliver programs that will help the communities, businesses, and workers affected by changes in defense spending. These activities will support the development of modernization and diversification assistance programs for businesses. Eligible recipients for these assistance programs will be identified through the Phase 1 data analysis and the Phase 2 resource fairs. Phase 3 includes the following projects:

11. Business assistance programs for affected suppliers (conducted by GO-Biz)

12. Contract diversification program (conducted by California Community Colleges Small Business Sector Navigator)

14. Innovation Hub competitive grant proposal/innovation voucher program (conducted by GO-Biz)

15. Entrepreneurial and business skills development program (conducted by California State University San Bernardino)

Note that the individual activities proposed in Projects 6-10 will be combined into multiple partner "resource fairs."

Project 7 - Regional Supply Chain Workshops

Background and Summary:

The California Community Colleges Small Business Sector under the "Doing What Matters for Jobs and the Economy" program of the Economic and Workforce Development (EWD) Division will organize and deliver ten Regional Supply Chain Workshops for small businesses impacted by reductions in defense contracting and procurement. These educational workshops will be one component of the multi-partner resource fairs. The workshops will convene California Community College education resource providers and small businesses to identify the workforce and business development related needs of these businesses and provide potential solutions to those needs. The regional workshops will be organized by the regional Deputy Sector Navigators for the Small Business Sector in the seven macro regions for the California Community College system which comprise the network of 113 Community Colleges. The Deputy Sector Navigators will work with their Regional Consortia to organize these workshops and bring the appropriate resource partners to the table.

Tasks:

- 1) Subcontract with a Project Coordinator to work with the regional Small Business Deputy Sector Navigators to organize, market, and deliver the Regional Supply Chain Workshops.

- 3) Develop outreach materials for the Regional Supply Chain Workshops.
- 4) Deliver a Regional Supply Chain Workshop in each of the ten regions across California.
- 5) Refer participants to follow-on business development and training opportunities offered through the programs and partnerships of the Community College Small Business Sector Navigator program, based on the participant needs. Note that the Community College Small Business Sector Navigators partner with local economic development corporations, chambers of commerce, community-based business outreach centers and other community-based organizations whose primary mission is to assist small businesses. Objective of the Activity:

Procurement:

Solano Community College as the host for the California Community Colleges Small Business Sector will manage these efforts, in partnership with regional Sector Navigators.

Project Schedule:

This task will continue throughout the 24-month grant period.

In addition, this phase will also support the gathering of foundational data related to the cybersecurity resilience projects of Phases 1-3. These subsequent cybersecurity activities will demonstrate that enhanced cybersecurity resilience can support modernization and diversification assistance goals, as well as enhance the innovation capacity and long-term sustainability of advanced industry supply chains within the defense sector. The Planning Phase includes the following projects:

- 1. Strategic alignment with other OEA plans (facilitated by GO-Biz)
- 2. Cybersecurity labor market analysis and skills gap analysis (conducted by California Community Colleges, San Francisco Bay Center of Excellence for Labor Market Research)

Phase 1 – Identify and analyze defense supply chain

The purpose of Phase 1 is to develop more specific data on the defense supply chain in California. This data will help to identify the communities, businesses, and workers that will be eligible for the subsequent Phase 2 and Phase 3 diversification, adjustment, and modernization activities. Phase 1 includes the following projects:

- 3. Cyber provider survey (conducted by California Manufacturing Technology Consulting)
- 4. Supply chain mapping (conducted by California State University San Bernardino)
- 5. Cybersecurity industry convenings (conducted by San Jose State University)

Phase 2 – Build awareness of supply chain resilience resources

Phase 2 activities will raise awareness of available resilience resources and programs for communities, businesses, and workers at risk of being negatively affected by changes in spending. In addition, Phase 2 activities will help strategic partners identify the workers and businesses that will be eligible for the diversification and adjustment programs provided in Phase 3. While the strategic partners responsible for Projects 6-10 submitted individual proposals, these supply chain resilience efforts will be combined into multiple-partner resource fairs. Each resource fair will offer a robust set of resilience programs and educational opportunities for attendees. As one potential example, a resource fair may include a supply chain resilience seminar (Project 6), a business diversification workshop (Project 7), and a cyber physical security awareness workshop (Project 8). Phase 2 includes the following projects:

- 6. Supply chain resilience seminars (hosted by East San Diego County Economic Development Council)
- 7. Regional supply chain workshops (hosted by California Community Colleges Small Business Sector Navigator)
- 8. Cyber physical security workshops (hosted by California Manufacturing Technology Consulting)
- 9. Cyber physical security assessments (conducted by California Manufacturing Technology Consulting)
- 10. Supply chain outreach (hosted by the Nehemiah Emerging Leaders Program)

Phase 3 – Develop business and worker resilience programs to bolster supply chain

During Phase 3, strategic partners will deliver programs that will help the communities, businesses, and workers affected by changes in defense spending. These activities will support the development of modernization and diversification assistance programs for businesses. Eligible recipients for these assistance programs will be identified through the Phase 1 data analysis and the Phase 2 resource fairs. Phase 3 includes the following projects:

11. Business assistance programs for affected suppliers (conducted by GO-Biz)

12. Contract diversification program (conducted by California Community Colleges Small Business Sector Navigator)

13. Commercialization pilot analysis (conducted by Santa Clara University)

14. Innovation Hub competitive grant proposal/innovation voucher program (conducted by GO-Biz)

15. Entrepreneurial and business skills development program (conducted by California State University San Bernardino)

Scopes of Work for California Advanced Supply Chain Analysis and Diversification Effort (CASCADE)

Note that the individual activities proposed in Projects 6-10 will be combined into multiple partner "resource fairs."

Project 12 - Contract Diversification Program

Background and Summary:

The California Community Colleges Small Business Sector under the "Doing What Matters for Jobs and the Economy" program of the Economic and Workforce Development (EWD) Division will develop and deliver a Contract Diversification Program for small businesses affected by reduced defense contracting and procurement to assist these businesses in diversifying into nondefense related contracting opportunities. The Contract Diversification Program will consist of nine not-for-credit online training modules coupled with technical assistance through Small Business Development Centers (SBDCs)/Procurement Technical Assistance Centers (PTACs), and access to a bid matching service to identify contracting opportunities.

The Cal Asian Chamber under a MOU with the California Community Colleges Small Business Sector will conduct the intake of businesses into the Contract Diversification Program and maintain the bid matching service for the project. The Cal Asian Chamber and the Small Business Sector will enter into MOUs with SBDCs and PTACs across the state to deliver the one- on-one technical assistance component of the project. There are currently 13 Community College hosted SBDCs in the state, but the Deputy Sector Navigators for the Small Business Sector also have existing relationships and MOUs with the non-community college hosted SBDCs as well. The Small Business Sector also has a Memorandum of Collaboration (MOC) in place with the six

regional SBDC networks across the state to collaborate on projects such as this.

The nine online Contract Readiness Modules were developed with funding from the Chancellor's Office and are hosted by Coastline Community College. Below is a listing of the nine online Contract Readiness modules:

Tasks

- 1) Subcontract with a Project Coordinator to work with the Cal Asian Chamber and Coastline Community College to modify and repackage the existing Contract Readiness Program with a focus on diversification.
- 2) Develop outreach materials for the Contract Diversification Program.
- 3) Identify Bid Matching Service to integrate into the Contract Diversification Program.
- 4) Set up MOUs with technical assistance providers (SBDCs and PTACs) in each of the ten regions across the state.
- 5) Conduct intake of businesses participating in the Contract Diversification Program.
- 6) Deliver online training, technical assistance and bid matching services to businesses participating in the Contract Diversification Program.

Note that the criteria for determining the firms to target for this contract diversification program will be developed in the Strategic Alignment Project and validated by the Steering Committee (see Project 1). These selection criteria will also be informed by the initial data gathered from the supply chain mapping activities (projects 3-5) and the cybersecurity skills gap analysis (project 2), as well as the supply chain resource fairs (projects 6-10).

Objective of the Activity

- Help businesses that have been adversely affected by reduced Defense Department procurement and contracting to diversify into non-defense contract opportunities.
- An estimated 100 businesses participate in the Contract Diversification Program over the two year period of the grant effort.

Procurement:

Solano Community College as the host for the California Community Colleges Small Business Sector will manage this project and contract with other partners, including the California Asian Chamber of Commerce and Coastline College.

Project Schedule:

This task will continue throughout the 24-month grant period.

- Modify and repackage the existing Contract Readiness Program modules with a focus toward diversification by September 2017.
- Identify bid matching service to incorporate into the program by October 2017.
- Set up MOUs with SBDC and PTACs in all ten regions of the state by November 2017.
- Identify businesses to participate from all ten regions by December 2017
- Provide intake services to businesses participating in the Contract Diversification Program ongoing as they enter the program.
- After completing the online training modules, the businesses participating are referred to technical assistance providers (SBDCs and PTACs) for one-on-one counseling and provided access to bid matching service.

GO-Biz Announces \$2.9 Million Federal Award to Bolster Cybersecurity Resilience and Innovation

Funds will also support business commercialization and diversification efforts and worker re-training opportunities

Sacramento, Calif. – The Governor's Office of Business and Economic Development (GO-Biz) and the Governor's Office of Planning and Research (OPR) announced today that California received a \$2.9 million grant from the United States Department of Defense-Office of Economic Adjustment (OEA) to expand the capacity of California businesses and workers to leverage the multi-billion dollar cybersecurity supply chain in the state. GO-Biz and OPR, along with academic, government, and non-profit partners, will develop and implement 15 business and workforce development projects designed to help communities respond to changes in federal defense spending and augment regional defense diversification plans.

Through the grant, GO-Biz, in partnership with a coalition of state agencies, community and educational institutions, will coordinate a variety of cybersecurity resilience activities. The project, called the California Advanced Supply Chain Analysis and Diversification Effort (CASCADE), will be a two year effort and activities will include: supply chain mapping, labor market and skills gap analysis, cybersecurity provider surveys, cyber physical security workshops and assessments, and other activities. CASCADE also provides funding for a variety of business and workforce development projects, including "innovation vouchers" for small businesses, as well as, assessments and entrepreneurial skills development efforts. Collectively, these 15 projects will expand access to cybersecurity resources and assistance for small and mid-size businesses and workers.

"The CASCADE program enables California companies and workers to tap into one of the fastest growing and diverse industry sectors in our state – cybersecurity," said Panorea Avdis, GO-Biz Director. "We will provide resources that will help them develop greater insight about procurement, entrepreneurship and labor opportunities in the sector. In addition, CASCADE will empower our defense industry business and people employed in the industry to enhance and diversify their skill sets and opportunities within cybersecurity."

The CASCADE effort will include more than a dozen government, academic, and community partners, including GO-Biz, OPR, Governor's Office of Emergency Services, California Community Colleges Centers of Excellence for Labor Market Research, California Community Colleges Small Business Sector Navigator, California Manufacturing Technology Consulting, California State University San Bernardino Institute of Applied Research, California State University Inland Empire Center for Entrepreneurship, San Jose State University, San Diego East County Economic Development Council, Nehemiah Community Foundation, Santa Clara University, City College of San Francisco-San Francisco Bay Center of Excellence and Employment Training Panel.

SOLANO COMMUNITY COLLEGE DISTRICT AGREEMENT FOR EDUCATIONAL SERVICES

This agreement is entered into by and between **SOLANO COMMUNITY COLLEGE DISTRICT**, hereinafter referred to as "District" and **Bay Area Clean Water Agencies**, hereinafter referred to as "BACWA."

WHEREAS, BACWA desires to engage the District to render special educational services,

THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- A. The District will provide for-credit classes as mutually determined for up to 30 students per class, for BACWA member organizations and other interested parties, provided member needs are met.
- B. The District will develop, coordinate, deliver, and evaluate the training. Instruction/training will be delivered at various BACWWE sites, to be determined. Classes will begin in Fall 2017, exact dates to be determined. Additional training can be scheduled as needed with an addendum to this contract.
- C. The District will maintain the BACWWE (Bay Area Consortium for Water & Wastewater Education) website and database and provide marketing and marketing materials for sponsoring agencies.
- D. Solano Community College and BACWWE will recruit, identify and select all trainees who will participate in training.
- E. Subject to availability of funds collected from sponsoring agencies, BACWA will compensate the Solano Community College District \$3,250 per 16 hours of instruction, which is equal to one credit hour. Therefore, one unit courses will be \$3,250; two credit courses will be \$6,500; three unit courses will be \$9,750; and four credit courses will be \$13,000. If courses involve a half credit an additional charge of \$1,625 will be added.
- F. Payments by BACWA to the District will be due upon receipt of invoice. An invoice will be generated upon completion of the first month of instruction.
- G. This contract may be terminated by either party upon written notice of not less than ten (10) business days.

- H. It is mutually understood that BACWA and the District shall secure and maintain in full force and effect during the full term of this Agreement, liability insurance in the amounts and written by carriers satisfactory to BACWA and the District respectively.
- I. The District will indemnify, and hold harmless, in any actions of law or equity, BACWA, its officers, employees, agents and elective and appointive boards from all claims, losses, damage, including property damages, personal injury, including death, and liability of every kind, nature and description, directly or indirectly arising from the operations of the District under this Agreement or of any persons directly or indirectly employed by, or acting as agent for the District, except to the extent caused by the sole negligence or willful misconduct of BACWA. This indemnification shall extend to claims, losses, damages, injury and liability for injuries occurring after completion of the services rendered pursuant to this Agreement, as well as during the process of rendering such services. Acceptance of insurance certificates required under this Agreement does not relieve the District from liability under this indemnification and hold harmless clause. This indemnification and hold harmless clause shall apply to all damages and claims for damages of every kind suffered, by reason of any of the District's operations under this Agreement regardless of whether or not such insurance policies shall have been determined to be applicable to any of such damages or claims for damages.
- J. BACWA will indemnify, and hold harmless in any actions of law or equity, the District, its officers, employees, agents and elective and appointive boards from all claims, losses, damage, including property damages, personal injury, including death, and liability of every kind, nature and description, directly or indirectly arising from the operations of BACWA under this Agreement or of any persons directly or indirectly employed by, or acting as agent for the District, except to the extent caused by the sole negligence or willful misconduct of the District. This indemnification shall extend to claims losses, damages, injury and liability for injuries occurring after completion of the services rendered pursuant to this Agreement, as well as during the process of rendering such services. Acceptance of insurance certificates required under this Agreement does not relieve BACWA from liability under this indemnification and hold harmless clause. This indemnification and hold harmless clause shall apply to all damages and claims for damages of every kind suffered, by reason of any of BACWA operations under this Agreement regardless of whether or not such insurance policies shall have been determined to be applicable to any of such damages or claims for damages.
- K. BACWA agrees that it will not discriminate in the selection of any student to receive instruction pursuant to the Agreement because of sex, sexual preference, race, color, religious creed, national origin, marital status, veteran status, medical condition, age (over 40), pregnancy, disability, and political affiliation. In the

event of BACWA's non-compliance with this section, the Agreement may be canceled, terminated, or suspended in whole or in part by the District.
