Micaela Chapa gave the following report:

Good evening members of the board. I would like to inform the Body of two Senate Bills passed by unanimous roll call vote at the September 19th ASSC meeting entitled Senate Bill 9 & 10.

Senate Bill 9 is a bill to enact a Resolution Against the Action to End DACA for Dreamers. This Bill was authored by ASSC President Cheyenne Rada and former President Kevin Butt. The ASSC Senate formally renounces the rescission of DACA. The ASSC gives its full support to California Community Colleges Chancellor Eloy Ortiz Oakley for his statement regarding DACA on September 5th, 2017. The ASSC will co-sponsor with the Legal Scholars Society who has partnered with the Berkeley American Civil Liberties Union (ACLU) to host two "Know Your Rights" workshops which will be an interactive workshop on September 26th and 27th from 10am to 12pm in room 1406 on the Fairfield Main Campus. These workshops are open to the public and will be focusing on immigration and assisting DACA students.

Senate Bill 10 is a bill to enact a Resolution to denounce violent groups and the actions of White Supremacists in Charlottesville, Berkeley and San Francisco. This Bill was authored by ASSC President Cheyenne Rada and former President Kevin Butt. The ASSC stands by the United States Congress in their Senate Joint Resolution 49, "rejecting White nationalists, White supremacists, The Ku Klux Klan, neo-Nazis, and other hate groups" The ASSC Senate formally renounces any associations with these violent groups.

Student Trustee Jacob Hinkle gave the following announcement:

There will be a new library within the next four years. Our current library is over 45 years old so this new library should be well received. The Governing Board was presented plans on how the project will progress. This fiscal year for 2017/2018, an architect/engineer firm will selected and the project design. The Summer/Fall of 2019/2020 is when they will do the bid and contract award for the construction. Construction should begin in November of 2019 and end May of 2021. By summer 2021, the new library should be occupied and the old library will be demolished. They have some ideas of where to put it but they are working on the details. The budget for the new library is over \$42.5 million. That is the combined figures of what the college is using and funds received by the state. Twothirds of the budget will be used for the library itself, not the equipment that will go in it. Whatever is left is what will be used for equipment and other things. The Graphics Department will be relocated but it is to be determined where exactly they will go. There will be focus groups to garner suggestions on what should go in the new library. The ASSC will be involved when it comes time to ask the students their opinions on the matter. For the open space after the demolition of the old library, there were ideas of making it an art gallery or a green-space but again, that will be determined at a later date. They it made it a point that it should be a place that students want to be at. For this semester, there will representative meetings, reviewing possible architect/engineer documents, recommending firms, and communicating the vision.
