8. REPORT OF ACTION IN CLOSED SESSION

The Board held Conference with Labor Negotiator and CCA/CTA/NEA. CSEA, and Operating Engineers-Local 39, and no action was taken.

The Board discussed Public Employee Discipline/Dismissal/Release and no action was taken.

The Board held Conference with Legal Counsel – Anticipated Litigation and no action was taken.

9. COMMENTS FROM MEMBERS OF THE PUBLIC (CONTINUED)

Ms. Nancy Hocke and Mr. Jonathan Perez, students from Communications 1 class, presented their speech assignment. Ms. Hocke spoke about free tutoring and math support, and Mr. Perez commended the SCC counselors on providing support with scheduling.

10. REPORTS (NO ACTION REQUIRED)

(a) Associated Students of Solano College (ASSC)

Kiana Azar gave the following report:

- We have approved funding requests for five clubs (PTK, The Human Collective, Drama Club, Environmental Club, and Robotics Club) and one department (Biology/Anatomy), and they should be receiving their funds shortly.
- Coming up, we have a series of events planned for Domestic Violence Week of Action, including a prevention workshop sponsored by SafeQuest on October 22nd, Sarah Rinkin's informational event about Human Trafficking on October 23rd, Lieutenant Travis' healthy dating seminar on October 24th, and a legal advisory event on October 25th.
- On October 31st, the ASSC will have a Halloween Costume Contest in the cafeteria lobby, where there will be prizes for the top three winners and candy for all participants. On the same day, we will have a "Mind Surfin" event in the cafeteria, which will include an illusion show, telepathy, mind reading, hypnosis, and memory and stress relieving techniques.
- In November, we will be hosting a Harvest Festival on the 8th, where we will have activities such face painting, a fall photo booth, pumpkin painting, and more along with prizes and a bake sale.
- Our Diversity Affairs Senator is also planning events, including guest speakers and activities for November, which is recognized by the ASSC as Native American Heritage Month.
- Dr. Slade and our executive board will be attending General Assembly next weekend, from October 25th through the 28th, where our Legislative Advocate will vote on this year's resolutions on ASSC's behalf.

(b) Academic Senate

Professor LaNae Jaimez gave the following report:

The Professional Development/Flex Cal committee provided another great day of FLEX activities on October 9th. There were several excellent professional development options addressing our college needs including support for assessment of SLOs, mapping of PLOs, guided pathways, On Course, Department meetings, retirement and professional development itself. The SESC hosted a lunch event with students, presentations on Teaching for equity and the SCC Social justice program. There was good participation and turnout.

I attended the State Academic Senate Area B meeting last Friday at De Anza College. We received updates on AB705, CID approval, OER, Strong Work Force, Guided Pathways and equivalency. I'm happy to report that the SCC Senate seems to be on task with the initiatives that are before us. I will serve as the SCC voting delegate at the State Senate Plenary session on Nov $1-3^{\rm rd}$. As usual we will be attending breakout session on pertinent topics and voting on a number of resolutions.

The Senate is hosting an EEO training for faculty led by Rita Cameron Wedding on Monday, October 29th from 3:00pm -5:00pm. Dr. Cameron-Wedding will be addressing implicit biases and how they may unknowingly influence us.

The Academic Senate held our October 15th Senate meeting in the Biotech Building in Vacaville. We received a warm welcome by the biotech faculty and were provided with a tour of the building. At this meeting we passed resolution 10.15.18 Undocumented Student Week of Action supporting the resolution you passed and resolved to participate in the Week of Action by having the SESC, a subcommittee of the Senate, sponsor an event which they did today. We also reviewed the Guided Pathways Key Performance Indicators and generated questions we would like to ask our students. Michael Wyly will be presenting a Guided Pathways update to you on Nov. 7th and Sarah Donavon will update you regarding the work Math faculty are doing toward becoming compliant with AB705.

The prioritization for full-time faculty hiring is in full process. The "Faculty Staffing Request" forms are due on 10/31/18 and will be shared with deans and the Senate on 11/5/18. On Nov 19th the Deans and Senate will meet to review the requests, and rankings will be completed at that time. S/P Esposito-Noy will present recommendations for hiring prioritization along with the rationale for any changes to the Senate on 12/3/18. The Senate would like to acknowledge that we appreciate this process.

(c) College Governance Council

Superintendent-President Esposito-Noy reported that VP Diamond presented the new funding formula at the last meeting. The Ethnic Studies degree and Social Justice ADT were also discussed and clarified questions about what we are moving toward.

In addition, S-P Esposito-Noy reported that Michael Wyly keeps us updated on the Guided Pathways program.

(d) Superintendent-President

The ALG Group had the first session on implicit bias training this morning with Dr. Rita Cameron-Wedding. The second session will be conducted in November.

Last night, the SCC Scholarship event gave out 182 scholarships totaling over \$179,000. We still have \$13,000 to hand out in the spring.

The Biotech open house is scheduled for October 24th and is open to the public.

The tennis tournament finished on Sunday and was livestreamed throughout the week. Solano College ran commercials during the livestream.

Lastly, Dr. Esposito-Noy read a letter from two community members who were at Solano College a year ago during the fire evacuations. The letter commended Dr. Rischa Slade and the SCC staff for all their efforts during the evacuation.

Before proceeding with further business, Board President Dr. Chapman announced the passing of a Travis School board member, Angela Weinzinger, and would like to dedicate this meeting in her honor.
