In addition to the recognition plaque and photo presented this evening, the Governing Board through the SCC Education Foundation have installed a bench recognizing Ms. Keith's 24 years of service to this District. The bench sits in front of Bldg 600 with a view of the house, Stonedene across the street. On the bench is a dedication plaque. We hope that Ms. Keith will find her way back to the campus and enjoy the view from the bench. Thank you for your service to our students, faculty, and staff. You have been a wonderful colleague.

Academic Senate President, Dr. LaNae Jaimez, and Professor Michael Wyly presented Ms. Keith with a flower arrangement and thanked her for her service and support to the Academic Senate. Professor Jim DeKloe, on behalf of Biotechnology, acknowledged Ms. Keith with the following:

On behalf of faculty members, administrators, and students, I wanted to congratulate you on your retirement and to thank you for many years of exemplary service to our college and to our county and communities. And I especially wanted to thank you personally for your support of our biotechnology program over the years.

You were there during the early days of the biotech program; you always showed a tremendous interest and support. The program successfully leveraged the expertise of the growing Solano County cluster of biotechnology companies and became the first college -2 year or 4 year - to emphasize the skills and knowledge that students would need to enter the manufacturing sector of the biotechnology industry. In the years since, we have shared and exported our curriculum and expertise to other biotech programs in over 40 states and 7 countries. At the core, the biotech program takes our county's students, who as you know often come from very modest backgrounds, and nurtures them into a career - not a job - a career. Even the entry-level students earn a living wage. But the field of Biotechnology offers a career with tremendous potential for upward mobility - many of our early students are now supervisors and managers.

Of course, since that founding, we have not been idle. We have continued to add and change to remain one of the pre-eminent programs in the country.

The Solano College Biotechnology program:

- Became one of only 15 colleges authorized to offer a Bachelor's degree.
- Opened the \$ 34 million biotechnology/science building in Vacaville one of the best facilities in the country.
- Offered three certificates and an Associate's degree the newest certificate is in Cellbased and Stem cell technologies – an emerging field that will be worth hundreds of billions of dollars in the near future.
- Added two new faculty positions for a total of four.
- Engages in extensive outreach to high schools currently we entertain one high school a week at our new facility students come to us from as far away as Orange County and Morro Bay.

- Were successfully awarded a National Science Foundation grant that funded our ability to host and train faculty from all over the country
- Became part of NIIMBL the National Institute for Innovations in Manufacturing Biologics – a \$ 250 million public-private partnership – we have submitted a grant application to them where Solano College would lead a partnership with community colleges from 40 states.
- Became part of a National Science Foundation stem cell grant
- Served as leaders in Bio-Link, the national consortium of biotech colleges
- Participated in a \$ 20 million Department of Labor grant

Worked with the City of Vacaville, the Solano Economic Development Corporation, and the Chambers of Commerce to try to bring new biotech companies to our county.

And.... That's a partial list.

I outline these accomplishments only to demonstrate and underscore the importance and impact of the program that you helped start and supported through the years. And although the program graduates often were not directly aware of your important efforts, they were the beneficiaries of those efforts.

Again, I outline these efforts to thank you for the role that you played in this legacy.

Kiana Azar, ASSC representative to the Board, provided the following report:

On February 4th, the first day of the events planned for Black History Month, early college high school students created artwork related to civil rights and Black migrations, and there was an excellent turnout for the event; some of the students' artwork will be displayed in the library in the near future in celebration of Black history and student participation. In addition to today's genealogy workshop, there will be 12 other events throughout the month, and the ASSC plans on completing the "My Migration Story Video Project" (in addition to the exhibit of Black migration patterns in the kiosk outside the 1400 building) in which students will share their migration stories in a brief video, and they will be compiled, edited, and posted to the ASSC YouTube channel by our P.R.O.

Our former Student Trustee, Jacob Hinkle, resigned last week, and the ASSC President, Estefanny Saenz, has proposed that our current Math & Science Senator, Caitlyn Griffin, take the position; Superintendent President Esposito-Noy will bring this to the board later this evening. A student by the name of Jasmine Thompson is also interested in the position, however she is not currently a member of the ASSC senate, as her application is still under review.

Since Club Promo Day, the ASSC has sworn in three new senators and a P.R.O., and has received several applications for senator and associate positions. Additionally, we received 100 student surveys, and found that some common answers to question number one, "What food options would you like to see on campus?" were sushi, Mexican food, and food trucks. For question number three, "If you could change one thing on campus to improve student life, what would it be?" some common responses were fixing the paint in the buildings, more regularly cleaning the bathrooms, and improving the Wi-Fi.

For Women's History Month in March, the ASSC is planning events related to this year's theme: "Visionary Women: Champions of Peace & Nonviolence." We hope to work together with Lisa Neeley to bring in women visionaries from Solano County as guest speakers and commemorate/create awareness surrounding women making a difference in the community.
