Prior to the motion, Vice President David Williams provided the following comments regarding Isaias Jacobo:

Isaìas Jacobo is resigning from the District after 20 years as a full-time Spanish instructor. Before that, he paid his dues working here for years as an adjunct instructor while also working for his alma mater, Pacific Union College, as an administrator. He received his bachelor's degree from Pacific Union and his master's degree from UC Davis. As a young man, he did some work on the land where Solano College now stands. This memory prompted him to remark, after he was hired, that coming to Solano to teach felt like "coming home." A talented artist, he lives in Angwin with his wife, Nancy. They have two children.

Fall 2020 was a rough semester for Isaìas, and transitioning to online teaching for the first time was probably the least of it. Catastrophic wildfire forced the couple to evacuate their home on two separate occasions, and they ultimately spent some 25 days away from home. Luckily, their house survived the fire, but once they were able to return, they were without electricity for almost two weeks. To teach, Isaìas had to go to an evacuation center, where they helped him find a space to work in and access wi-fi. These were extreme challenges, which he met with his characteristic steady hand and calm demeanor.

Isaìas loved being in the classroom and sharing his love for Mexican culture with students. His classes were famous for making tortillas and for performing funny scenes from a telenovela called ¿Que Hora Es? He started a student interest group called SOL, helped organize Cinco de Mayo and Latinx graduation events with Michelle Arce, and participated with enthusiasm in the annual Foreign Language Night, singing with his students. Isaìas may be a quiet person who rarely talks about himself, but he's a terrific listener, serving as a kind of counselor figure to his thousands of students—and they loved that about him.

Longtime colleague Margaret Abel-Quintero remembers Isaìas as "a nice, steady, even-tempered person to work with; a gentle person who was very passionate about his culture and very fond of his students. He liked talking to them and encouraging them on their life path. He liked to sing with them and talk about Mexico." As a colleague, she said, he would take any assignment without complaint, and she routinely saw him on campus working long hours, "morning, noon, and night." When the School of Liberal Arts held a student recruitment event a few years ago, Margaret says, Isaìas brought his "little comal" to demonstrate tortilla-making, explaining how to mix the masa, shape the tortilla, and teaching the history, as well, something he did in class each semester. He loved to do hands-on demonstrations, appreciating how much this kind of teaching spurred his students' interest and enthusiasm, and this particular one would fill the hallways of the 700 building with an appetizing smell.

Liberal Arts Dean Neil Glines, who notes that he and Isaias were hired as full-timers at the same time, regrets that his last scheduled evaluation session with Isaias was supposed to be one of these famous tortilla-making sessions, but the scheduled evaluation had to be postponed indefinitely once the pandemic started. We wish "Renaissance man" Isaias many happy years of retirement to devote to his family, his art, his home improvement projects—and hopefully traveling, too, whenever it's safe again.

Vice President David Williams provided the following comments from Lisa Neeley, Dean of Applied Technology and Business regarding Mike Goodwin:

Professor Mike Goodwin, US Air Force veteran and retired law enforcement officer, is described by his colleagues as a "consummate professional," a "great mentor," and a "steady hand." As the lead Criminal Justice instructor, Mike's fellow instructors characterize him as "someone who is honest, forthright, and definitely the 'go to' person to bounce things off of or approach with a problem."

Long-time SCC colleague and friend, Keith Twitchell, remarks that he has "observed Mike's teaching style, professionalism, and most of all, his total commitment to the betterment of all his students. He is always current in his knowledge of the many changes constantly taking place in law enforcement, the courts, and corrections. I can't recall how many times over the years Mike and I discussed the always changing CJ horizon, always seeking better ways to help our students further their academic and vocational careers."

This sentiment is echoed by students who flock regularly to his popular classes over the years, and rate him highly during student evaluations. In fact, according to Rate My Professor, the most common tags attributed to Professor Goodwin's classes are "amazing lectures," "inspirational," and "respected." One student noting enthusiastically, "he will literally make you want to go to class and learn!"

In my very short time here at the college I have thoroughly enjoyed working with Professor Goodwin, finding him to be dedicated to his students' success, extremely knowledgeable, collaborative, forward looking and incredibly authentic. Prior to COVID-19 we had animated and robust discussions about the latest course he developed in the area of multi-cultural policing, and the critical need to move the conversation about how we teach the administration of justice forward.

Solano Community College is richer for Mike Goodwin's service, and his presence leaves a lasting impact on the District, his colleagues and our students.

Vice President Shannon Cooper provided the following comments regarding Nancy DiPasquale:

Nancy has spent the past 30 years working in the FA Department at Solano and during that time she has helped countless students through the process and onto their goal of graduation. Nancy has always served students with a smile and has been a true team player. We are happy for her decision to retire and to go out and enjoy life. She will be missed!
